CONCLUSION

The overall observations of the academic audit committee based on input collected from all departments are

- More than 95% percent of faculty members are regular appointees of the Government.
- Course delivery is conducted as per the curricula of the university.
- Department meetings are regularly conducted.
- Classes are conducted as per the timetable and records are maintained.
- Smart classrooms are utilized by teachers and students.
- Internal evaluation is fair and transparent.
- Faculty members actively participate in the administrative process.
- Departments conduct seminars and workshops.
- The pass percentage is high compared to university average for many of the programmes.
- Student placement and employment is at mediocre level.
- Many students are unable to qualify national level competitive examinations.
- Laboratory facilities are sufficient and at par with national level in some departments.
- Many of the science departments offering only UG programme have good infrastructure adequate for starting of PG courses.
- New equipment and books are purchased.
- Departments have purchased equipment and software using research grants.
- The innovative methods and extension activities of the college help to develop socially responsible citizens.
- Students actively participate in college level programmes.
- The dropout rate of students is low.

Based on the aforementioned observations, the committee recommends the following suggestions for the improvement of the academic performance of the college.

- Smart rooms may be more effectively utilized by employing specialized software.
- Tutorial and remedial systems may be centrally organized.
- Coaching programmes may be effectively conducted for NET/SET/PG entrance etc.
- Class log may be maintained in each class in addition to teachers' diary.
- Study materials may be made available using *Moodle*.
- Faculty members may take up more research projects.
- Faculty members may publish more research papers in peer reviewed journals.
- Faculty members with Ph D may take up research guidship and research centers may be established with the approval of the university.
- More PG programmes may be started in science departments.

It is hoped that the academic audit will help the college in its quality enhancement process and in developing the future plans of the college.
